RESOLUTION NO. 22-26

A RESOLUTION APPROVING THE CREATION OF THE PIKE COUNTY WOMEN'S COMMISSION AS A COUNTY COMMITTEE

WHEREAS, the Commissioners of Pike County recognize the significant contributions women have made throughout our nation's history, women have worked for social and economic justice, serviced the United States through its armed services, nurtured families in the home, and made significant contributions in science, medicine, education, commerce, government, and the arts; and

WHEREAS, the Commissioners establish the Pike County Women's Commission to encourage and empower girls and women to think larger and bolder, acknowledge their work in the advancement of women and girls, highlight the achievements of women in Pike County, and give boys and men a fuller understanding of women's abilities and rights; and

WHEREAS, in Pike County, the Pike County Women's Commission will advocate for women, acknowledge their contributions to the history of the county and empower women in their roles both at home and in the workforce, raise awareness on issues such as mental health, women's health, financial independence and prevention of violence against women; and

WHEREAS, the Pike County Women's Commission shall serve as an advisory commission to the Pike County Commissioners for the purposes of evaluating the concerns and needs of women and girls residing in Pike County and making recommendations to the County Commissioners as to how to meet those concerns and needs; and

WHEREAS, the Pike County Women's Commission will work towards the advancement of women and girls of all backgrounds in Pike County, its townships and the Commonwealth; and

WHEREAS, the goals stated herein can best be accomplished by marshalling the personnel resources available to both within and outside of Pike County under the umbrella of a Commission authorized by the Commissioners of Pike; and

NOW, THEREFORE, IT IS HEREBY RESOLVED:

- That the Pike County Commissioners do hereby appoint, recognize and create the Pike County Women's Commission.
- 2. The members of this Commission shall be appointed as volunteers of the County for these purposes.
- 3. The Commission members shall be afforded the rights, powers and privileges accord to such County Volunteers including but not limited to liability insurance coverage provided by the County.
